- Did Indian nationalism between 1885 and 1920 develop in response to British policies of 'native representation'?
- 2 To what extent has Gandhi's role in the development of popular nationalism in India been exaggerated?
- Why and how did the British seek to hold on to power in India between 1920 and 1945, and to what extent did they succeed?
- Why did the Muslim League perform so much better in the 1946 elections than they had done in those of 1937?
- 5 **EITHER**: (a) Has the role of Hindu communalism in India's partition been underestimated?
 - **OR**: (b) Did partition create more minority problems than it solved?
- 6 **EITHER**: (a) What has been distinctive about movements of Islamic resurgence and reform in the twentieth century? Answer with reference to one or more South Asian countries.
 - **OR**: (b) To what extent have Islamic movements in South Asia since 1947 accepted or opposed the notion of a secular state? Answer with reference to one or more South Asian countries.
- 7 To what extent was one-party dominance in India between 1947 and 1967 based on consensus inside the Congress party?
- 8 What role did economic planning play in shaping India's polity between 1947 and 1967?
- 9 To what extent has India's development been hampered by overcentralisation?
- Why did the question of a national language pose such serious challenges to either India or Pakistan between 1947 and 1970?
- 11 Did the Emergency, paradoxically, strengthen democracy in India? (TURN OVER

- 12 To what extent have the imperatives of the 'Great Game' remained pertinent to South Asia since 1947?
- 13 Have Indo-Pakistani wars been essential to the respective national identities of their participants?
- Why did the consensus about positive discrimination on the basis of caste in India break down in the 1980s?
- To what extent has the Bharatiya Janata Party succeeded in becoming India's 'second party'?
- Were the Taliban simply Pashtun chauvinists who dressed themselves in the rhetoric of Islamic fundamentalism? Discuss with regard to the period 1992 to 2001.
- 17 Discuss why martial rule has been such a feature of the history of **either** Pakistan **or** Bangladesh since 1971.
- 18 To what extent is the Government of India responsible for the continued lack of resolution of the Kashmir conflict?
- 19 Are better forms of resource allocation and more targeted social programmes likely to improve India's social indicators?
- Why have the communist parties of India enjoyed strong support in particular regions and not in others?
- 21 To what extent have women been integrated into the structures of power in independent India?
